

## Privacy Statement NodeXS

This is the privacy statement of NodeXS. NodeXS is registered with the Chamber of Commerce under number 80245455 and is located at Vogelwikke 4 (2435WH) in Zevenhoven. This document explains how NodeXS handles the processing of your personal data. In processing your personal data, NodeXS exercises the utmost care.

### Acquisition of personal data:

If you use the services of NodeXS, you yourself provide a number of personal data to NodeXS, or personal data is obtained from you as part of the agreement. Personal data means all data relating to identified or identifiable natural person.

### Categories of personal data

NodeXS processes the following categories of personal data:

1. Contact and name and address information;
2. IP Address
3. Company data;
4. Financial data;
5. Account information, which also includes your password and username;
6. Other personal data provided by yourself.

### Purpose of processing

The personal data processed by NodeXS is for the purpose of:

1. Contacting you to inform you of the services you have purchased and their performance;
2. Performing its services;
3. Improving services;
4. Making payments;
5. Compliance with legal obligations;
6. Doing marketing and communication expressions;
7. Improve the website by analyzing visitor behavior on the website;
8. Sending newsletters;
9. Data exchange with third parties for the purpose of service delivery.

### Basis of processing

The processing of personal data is only possible under the following bases: (i) legal obligation, (ii) execution of agreement, (iii) obtained (explicit) consent of those involved, and (iv) legitimate interest. Personal data are processed when providing the services of NodeXS. NodeXS only processes data which NodeXS considers necessary for (the improvement of) its services and treats with care the

(personal) data it has collected about you and your use of the services. The basis for processing these data is the agreement you have entered into with NodeXS. Personal data of you may also be processed by visiting the website [www.nodexs.com](http://www.nodexs.com) if you have given your consent.

## **Need processing**

The processing of your personal data is necessary to perform the services. The services provided by NodeXS cannot be fully performed without the processing of your personal data. If specific purposes related to personal data require your explicit consent, you must give your consent separately.

## **Automated decision-making**

There is no automated decision-making.

## **Retention period**

Personal data processed by NodeXS are retained in accordance with the relevant laws and regulations. If a longer retention period is necessary under laws or regulations, the personal data will be kept longer in accordance with these requirements. All (obtained) personal data will not be kept longer than strictly necessary.

## **Third party processing**

NodeXS only shares personal data with third parties if strictly necessary for the execution of an agreement and to comply with relevant laws and regulations. No personal data is sold. NodeXS may have a legal obligation to share personal data with third parties. If personal data is shared with third parties, processing agreements are concluded for this purpose. The third parties with whom personal data is shared are:

1. Software suppliers, for the purpose of executing the agreement. The categories of personal data processed are contact and name and address data.
2. Website administrator, for the purpose of executing the agreement. The categories of personal data processed are contact and name and address information.

NodeXS takes the protection of your personal data seriously and in this regard, taking into account the state of the art, implementation costs, as well as the nature, scope, context and purposes of processing and the risks to the rights and freedoms of individuals that vary in terms of probability and severity, takes appropriate technical and organizational measures to ensure a level of security appropriate to the risk.

## Use Social Media

NodeXS uses third-party cookies to optimize the website. Some cookies are set by third-party services displayed on the website. Third parties refers to Google Analytics and Social Media (LinkedIn, Facebook, Twitter). ## Right of data subjects

As a data subject, you have the following rights:

1. Right of inspection;

2. Right to rectification;  
You have the right to obtain rectification and completion of inaccurate data.
3. Right to data erasure;  
Without unreasonable delay, a data subject must obtain erasure of personal data concerning him.
4. Right to restriction of processing;
